  - The members of the Executive Committee (Government Body) shall be day board to attest the signatures of all the members newly elected Executive Committee (Governing Body) and to see that the said signatures of the out-going governing body tally with annual list as filled with the Register of societies before 15 days of the succeeding months of the month in whi8ch elections were held.

1. PRESIDENT He/she pres

He/she presides over all the meting of the both general body and executive committee. He/she can caste his both in the position. He/she can supervise all the branches of the society.

2. VICE-PRESIDENT

He/She shall assist the president in discharging his/her functions. In obscene of the president he/she will perform the duty of the president as entrusted to him/her.

3. GENERAL SECRETARY CORRESPONDENT :

He is the chief Executive Officer in the Society and custodian to all records relating to the society and correspondent on behalf of the society he has to take on records of al minutes of society to convene both bodies of the society. He will be responsible for all accounts. He guides the Treasurer in preparing the budget and expenditure statement to put before the general body of its approval. He will be responsible for all official works etc.

4. JOINT-SECRETARY : He has to work as entrusted by the Executive Committee. He

has to assist the secretary in discharging his duties. In the absence of the Secretary he can perform the duties of the

secretary.

5. TREASURER : He is the responsible person of all the financial transaction

relating to the society. He has maintain accounts and withdrawal of bank amount. He has to prepare the budget with expenditure statement with the guidance of the secretary.

6. OFFICE BEARERS : The are the responsible persons to do the activities of the

society which the executive committee entrusted to them.

7. QUORUM : Half of the total member for General Body meeting and ½ and

for executive body meeting.

8. FUND : The funds shall be spent only to the public interested activities

9. LOANS, DONATIONS: The Academy is having rights to borrow loans from the

nationalised banks, finance corporations and accepted donations from any agency. All the members are responsible

for the above loans and donations.

10. BANK TRANSACTIONS: The Vice-President and Treasurer responsible for all bank

transactions.

11. AMENDMENTS : No amendments or alteration shall be made in purpose of the

Association unless it is voted by 2/3rd of its members of

society at a second special meeting.

12. WINDING UP : In case the society has to be woundup the property and funds

of the society that shall be transferred or paid to some othe

institutions with similar aims and objects.
